#### WHEN AND WHERE IS THE SHAREHOLDER MEETING?

The 2024 Annual Meeting of Shareholders of Metallus Inc. will be held on Tuesday, May 7, 2024, at 10:00 a.m. Eastern time, in an online-only format, at <a href="https://www.cesonlineservices.com/mtus24">www.cesonlineservices.com/mtus24</a> vm. You will not be able to attend the meeting in person. #### WHAT IS BEING VOTED ON AT THE SHAREHOLDER MEETING?

1. Election of four Class I directors, each to hold office for a three-year term expiring at the 2027 annual meeting, and election of one Class II director to hold office for a one-year term (the remaining term for that class of directors) expiring at the 2025 annual meeting:

Class I Nominees: Mary Ellen Baker, Jamy P. Rankin, Ronald A. Rice and Michael S. Williams

Class II Nominee: Melissa M. Miller

- 2. Ratification of the selection of Ernst & Young LLP as the company's independent auditor for the fiscal year ending December 31, 2024.
- 3. Approval, on an advisory basis, of the compensation of the company's named executive officers.

### WHAT DOES THE BOARD OF DIRECTORS RECOMMEND?

The Board of Directors recommends that shareholders vote <u>FOR ALL</u> nominees listed in proposal 1, and <u>FOR</u> proposals 2 and 3.
